3.2. The Chairman proposed that the annual account presented by the secretary on behalf of the treasurer was a true reflection of our account since our last AGM. The meeting unanimously agreed that the annual account was a true reflection of our annual account.

## Item 4 – Amendments to constitution

4.1 The secretary purposed changes to article 5 of our constitution (Membership). The changes he purposed was; whether to reduce membership fee to £1.00 or remove it completely.

4.2 After healthy discussion on this, the Chairman explained that unless we have an automated system where individual can apply for membership online, pay for it online and get a membership card online, it would be extremely difficult to track age and issue membership manually where human interface is required to update it. For that reason, the Chairman purposed to remove the membership fee and replace article 5 of our constitution as follows:

*"5.1 All Nepalese residing in the Oxfordshire shall be eligible for full membership of the organisation regardless of age but must pass 18th birthday to be eligible to cast a vote or contest in the election.* 

5.2 Everyone residing in Oxfordshire and registered in Oxfordshire Nepalese database shall be granted membership for free unless no intention to join this organisation is received from the member.

5.3 Any member wishing to relinquish their membership must notify the executive committee member to remove their name(s) from the Oxfordshire Nepalese database."

4.3. The meeting unanimously agreed to replace the Article 5 of our constitution as purposed by the Chairman.

# Item 5 – Safeguarding Policy

5.1. The Chairman informed the meeting that community is now holding a Safeguarding Policy as required by the Oxford City Council.

# Item 6 – Connecting People Together (CPT)

6.1. The secretary updated the meeting about the CPT project and asked everyone to join the project on 4<sup>th</sup> September 2022 and every Sunday then after. He further stated that the IT equipment (Laptop and Projector) bought for this project will remain the property of National Lottery and will stay with the project co-ordinator throughout the project.

# Item 8 – AoB
